Recommendation

Staff recommends the City Commission approve a resolution finalizing the transfer of Cityowned property located at 1200 NW 3 Street (Folio ID 504204200450) in the Northwest-Progresso-Flagler Heights Community Redevelopment Area and 1145 NW 5 Avenue (Folio ID 494234037570) in the Central City Community Redevelopment Area to the Fort Lauderdale Community Redevelopment Agency (CRA), Pursuant to Section 8.02 of the City Charter

Background

On November 7, 2024, the City Commission of Fort Lauderdale approved Resolution 24-222, declaring its intent to convey two city-owned properties located at 1200 NW 3 Street and 1145 NW 5 Avenue (Exhibits 1 through 3) to the CRA for affordable housing purposes. The resolution outlines conditions for the conveyance, including compliance with redevelopment plans, assumption of associated costs by the CRA, and acknowledgment of existing leasehold interests.

As stipulated in Section 8.02 of the City Charter, the City is authorized to convey real property it owns to another public entity for a public purpose that serves the public interest. This item will approve the final conveyance of 1200 NW 3 Street and 1145 NW 5 Avenue to the CRA for an affordable housing purpose.

The conveyance is subject to a covenant restricting occupancy of the property to families with low-to moderate-income with a total household annual gross income that does not exceed the 80% area median income.

Resource Impact

There is no fiscal impact associated with this item.
