**TITLE:** A Motion approving the Second Amendment to the Interlocal Agreement  
with Broward County for Community Bus Service

---

**Recommendation**

It is recommended that the City Commission approve an amendment to the Interlocal Agreement with Broward County for the “Neighborhood Link” Community Bus Service.

**Background**

The City has an Interlocal Agreement (ILA) with Broward County for the provision of “Community Bus Service,” approved by Resolution 09-222 (Exhibit 1) on September 15, 2009 and amended on June 5, 2012.

As required by Section 2.1.3 of the ILA and per provision of 49 USC Section 5307(d)(i)\*, the City Commission held a public hearing on December 18, 2012. This hearing was to seek public input on the combination of the former Housing Authority of the City of Fort Lauderdale’s (HACFL) Blue and Red Routes and the reduction of daily service hours. At that meeting, the City Commission also renamed this combined route to “Neighborhood Link.” These modifications in service have been determined to affect 25% or more of the route and therefore require an amendment to the ILA.

With the service change and the reduction in weekly service, the maximum amount of Broward County funds for this service for the 2012-13 fiscal year is \$23,812.50.

The Broward County Commission approved the Second Amendment to the ILA at its January 8, 2013 meeting. In that approved ILA amendment there was a Scribner’s error on its Exhibit “F” which will require the ILA to return to the Broward County Commission for approval in February of 2013.

**Resource Impact**

This item replaces CAM #13-0073, companion item to Section M of the consolidated budget amendment (CAM #12-2644) approved at the January 8, 2013 meeting. The budget appropriation CAM #12-2644 was contingent upon, and will become effective with, the approval of this item (the agreement).
