<u>SECTION 1</u>. That the scheduled July 2, 2019, Conference and Regular Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to July 9, 2019, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on July 9, 2019.

<u>SECTION 2</u>. That the scheduled October 1, 2019, Conference and Regular Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to October 2, 2019, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on October 2, 2019.

<u>SECTION 3</u>. That the City Clerk shall publish this resolution once in the official newspaper of the City at least three (3) days before July 2, 2019.
