Fellowship RCO provides Supportive Recovery Housing to 200 men and women by delivering peer-based recovery support services. Additionally, FRCO operates 2 Recovery Community Centers outfitted with a robust Peer Support Program that employs a workforce of 16 Certified Peer Specialists. Additionally, we operate the only Substance Use Respite in Southeast Florida providing the community with 25 lifesaving beds for persons with SUD.

Through our Recovery Community Centers, Recovery Residences, and Respite Facility we have served over 30,000 individuals in the past 20 years; providing housing, recovery support services, back to work programs, back to school programs, support group meetings, life skills, Narcan training, and much more...



What is Peer Support?

• Peer Support encompasses a range of activities and interactions between people who share similar experiences of being diagnosed with mental health conditions and substance use disorders, or both. This mutuality between a peer specialist and person in or seeking recovery promotes connection and inspires hope. Peer support offers a level of acceptance, understanding, and validation not found in many other professional relationships (Mead & McNeil, 2006). By sharing their own lived experience and practical guidance, peer specialists help people to develop their own goals, create strategies for self-empowerment, and take concrete steps towards building fulfilling, self-determined lives for themselves.

EAM #25-1062 Exhibit 1 Page 3 of 12 Mutual – Peer Specialists have lived experience in recovery from a Substance Use Disorder and/or a Mental Health Condition, this lived experience builds a level of trust almost immediately.

Inspirational – Peer Specialists are evidence that recovery is possible, they share hope with the people they serve and provide inspiration for their recovery.

Motivational – Peer Specialists use tools such as motivational interviewing to help guide participants to process their decision making to make the best possible decisions in their recovery journey.

Navigational – Peer Specialists are well versed in the system of care in Broward County and are highly effective in linking participants to the services they need (Mental Health, Medical, Housing, Treatment, Identification etc.)

FRCO Peer Specialists have engaged over 150 individuals in Community Court since March 2025.

73 Referrals to the Respite / Recovery Housing have been made for persons experiencing homelessness with Substance Use Disorder.
