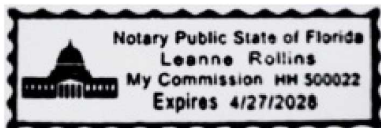

The City of Fort Lauderdale, as a recipient of the Federal Community Development Block Grant – Disaster Recovery (CDBG-DR) funds from the U.S. Department of Housing and Urban Development (HUD), invites the public to review and comment on its draft CDBG-DR Action Plan. The City of Fort Lauderdale has been awarded \$88,051,000 to address the impacts of the April 2023 Flood. These funds may be used to repair housing damage, restore infrastructure, enhance services, and strengthen community resilience against future disasters.

Public Comment Period

The Draft Action Plan will be available for public review and comment for a period of 30 days, beginning on September 6, 2025, and ending on October 6, 2025.
