- **TITLE:** Motion to award a contract with Weekley Asphalt Paving, Inc. for taxilane Charlie pavement rehabilitation and replacement of airfield lighting – P11749 – Invitation to Bid (ITB) 433-11279 - \$1,236,359.60

Recommendation

It is recommended that the City Commission award a contract for the purchase of taxilane Charlie pavement rehabilitation and replacement of airfield lighting to the lowest cost, responsive and responsible bidder, Weekley Asphalt Paving, Inc., in the amount of \$1,236,359.60.

Background

Taxilane Charlie is located west of runway 13-31 and provides access to the airfield to various tenants. The pavement condition index value for Taxilane Charlie was rated as 50 out of 100 (poor condition) in the Florida Department of Transportation (FDOT) Statewide Airfield Pavement Management Program Report, completed in 2012. This rating is below the FDOT recommended minimum level of 65, and requires rehabilitation to prevent further deterioration.

In addition to the pavement rehabilitation, the airport is also replacing the existing taxiway edge lighting fixtures with new light emitting diode (LED) fixtures. These LED light fixtures will improve visibility of the airfield, reduce maintenance, and reduce replacement costs associated with lighting strikes and life-cycle compared to the existing quartz edge lights.

Design of this project was completed in May 2013 by the airport's general aviation consultant, Kimley-Horn and Associates, Inc., and advertised on June 12, 2013 through the City's Procurement Services Division. Due to a technicality regarding the bid opening date, staff recommended that the City Commission reject all bids and allow City staff to rebid the project. This recommendation was approved by the City Commission at their August 20, 2013 meeting (CAM 13-1004).

The project was re-bid on August 28, 2013 and bids were opened on September 25, 2013. Weekley Asphalt Paving, Inc. was the lowest cost, responsive and responsible bidder in the amount of \$1,236,359.60. This amount is less than the Engineer's estimate of \$1,348,460. City staff has reviewed the qualifications and references of Weekley Asphalt Paving, Inc., and verified that they have sufficient experience and ability to perform the work required per the ITB terms, conditions, plans and specifications.

Funds for this contract award are available from the Airport's Capital Projects fund and from a Joint Participation Agreement with FDOT for reimbursement of 80% of eligible construction costs.

This item was reviewed and approved at the Airport's Aviation Advisory Board meeting on October 24, 2013.

Resource Impact

Contingent upon approval of agenda item #13-1472, the consolidated budget amendment, there will be a fiscal impact to the City in the amount of \$1,236,359.60 for the contract and \$123,635.96 (10%) for engineering fees for a total cost of \$1,359,995.56.
