

# **CITY OF FORT LAUDERDALE PROPOSED HOME PROGRAM AMENDMENT**

The City of Fort Lauderdale is considering amending its FY 18-19 Annual Action Plan of the 2015-2019 Consolidated Plan HOME housing rehabilitation/replacement programs. In accordance with the substantial change policy of the City's HUD approved Consolidated Plan, any change in HOME assisted activity as a result of the addition or cancellation of a program or a change in the purpose, scope, location or beneficiary of an activity, requires a program amendment to the Annual Action Plan of the Consolidated Plan. The City of Fort Lauderdale's program amendment and substantial change policy requires Commission approval and public input at a public hearing after proper notice has been published for a 30-day public comment period.

The proposed amendments as requested by the Fort Lauderdale City Commission, would allocate the funding for rehabilitation repairs.

- Allocate up to \$290,000 in FY 2018-2019 HOME funding for housing rehabilitation/replacement program.

These are federal funds and have no impact on the City's general fund budget. This amendment is in accordance with HUD regulations and allows the projects to proceed to completion.

In accordance with federal regulations, the City is hereby establishing a 30-day public comment period to receive input on the proposed to its Annual Action Plan of the Consolidated Plan. Comments on the proposed change(s) may be submitted to the City of Fort Lauderdale, Housing & Community Development Division: 914 Sistrunk Blvd, Suite 103, Fort Lauderdale, Florida 33311. Public comments on these items will be accepted during the 30-day public comment period from October 6, 2018 to November 5, 2018. All comments must be received by November 5, 2018.

The City will evaluate all comments received during the comment period, and the final amendment will be submitted at a public hearing on November 6, 2018. Public input will also be accepted at this public hearing on this amendment. A copy of the final amendment will be available for public review at the Housing and Community Development Division at the above address during regular office hours. At the close of the public hearing, the City's Commission will consider a motion approving the program to the FY 2018-2019 Annual Action Plan of the 2015-2019 Consolidated Plan.
