

RESOLUTION NO. 23-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE CITY OF FORT LAUDERDALE'S FY 2023 FINAL ALL FUNDS BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022, AND ENDING SEPTEMBER 30, 2023, AS AMENDED, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #23-0086, AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 22-220, adopted on September 12, 2022, the City Commission of the City of Fort Lauderdale, Florida, adopted the FY 2023 Final All Funds Budget for the City of Fort Lauderdale for the Fiscal Year beginning October 1, 2022, and ending September 30, 2023;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City of Fort Lauderdale's FY 2023 Final All Funds Budget for the Fiscal Year beginning October 1, 2022, and ending September 30, 2023, as amended, is hereby amended by appropriating funds as set forth in City Commission Agenda Memo #23-0086, a copy of which is attached hereto and incorporated herein.

SECTION 2. That if any clause, section, or other part of this Resolution shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Resolution shall not be affected thereby, but shall remain in full force and effect.

SECTION 3. That this Resolution shall be in full force and effect upon final passage.

TITLE: Resolution Approving the Consolidated Budget Amendment to Fiscal Year
2023 – Appropriation - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission adopt a resolution amending the Fiscal Year (FY) 2023 Operating Budget.

Background

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff recommends the City Commission amend the FY 2023 Final Budget, as revised, by approving the following transfers and appropriations:

Development Services

A. Appropriation of Fund Balance – Beach Business Improvement District (BBID) Fund, General Fund – NHL All-Star Weekend Support – \$175,000

The BBID wants to support the Florida Panther Hockey Club LTD in the amount of \$125,000 to produce the NHL All-Star Weekend event scheduled for February 2-February 4, 2023. The BBID Advisory Committee unanimously approved the funding request at the January 9, 2023 BBID Advisory Committee meeting.

There will also be a General Fund contribution in the amount of \$50,000 to support free events offered to the public throughout the weekend by Florida Panthers Foundation, Inc..

The National Hockey League (NHL) All-Star Weekend is an annual event produced by the NHL with rotating host cities. In 2022 it was held in Las Vegas, 2020 in St. Louis, 2019 in San Jose, and 2018 in Tampa. This event hasn't been hosted in South Florida since 2003.

The NHL All-Star Weekend is comprised of a series of events, hospitality functions, media opportunities, broadcast properties and grass roots fan activities that will be hosted throughout Broward County, including the Fort Lauderdale Beach area. All-Star festivities attract all 32 clubs within the National Hockey League as well as national corporate sponsor brands who attend to activate their brands and entertain VIP guests. The All-Star Weekend features multiple events including Truly Hard Seltzer NHL All-Star Beach Festival, All-Star Player Red Carpet, NHL All-Star Beach Bash, and Mascot Challenges. The weekend culminates with the NHL All-Star Game on Sunday February 4, 2023.

Prior to the event weekend, The Florida Panthers will host a Fort Lauderdale beach clean-up on Sunday January 29, 2023, to prepare for the arrival of fans and players. The clean-up will be attended by the Florida Panther's staff, NHL personnel, season ticket members, local community officials and volunteers.

Staff recommends the City Commission amend the FY 2023 Operating Budget in the amount of \$175,000 to support the NHL All-Star Weekend Event. There are two associated CAMs 23-0115 and CAM 23-0173.
