- TITLE: Motion Approving FY 2025 Beach Business Improvement District (BBID) Grant Participation Agreement with Lauderdale Air Show, LLC - \$75,000 – (Commission District 2)

Recommendation

Staff recommends the City Commission approve the FY 2025 Beach Business Improvement District (BBID) Grant Participation Agreement with Lauderdale Airshow, LLC to produce the Fort Lauderdale Air Show in the amount of \$75,000.

Background

In 2024, the Beach Business Improvement District (BBID) Advisory Committee reviewed grant requests for FY 2025. On April 8, 2024, the committee considered a \$100,000 request from Lauderdale Air Show, LLC to support the Fort Lauderdale Air Show, scheduled for May 10-11, 2025. The BBID Advisory Committee unanimously recommended a \$75,000 grant (Exhibit 1).

The Fort Lauderdale Airshow is an aerial exhibition of military and civilian aircraft and parachute teams. The 2025 event is scheduled for May 10-11, 2025, along State Road A1A on Fort Lauderdale Beach. Funds from the BBID will be used to supplement marketing and operational expenses associated with the event. The BBID Grant Funding Application provides further details of the event (Exhibit 2).

Funding History

The Fort Lauderdale Air Show received funding in 2013, and from 2016-2024, for a total amount of \$975,000.

The BBID Assessment is a non-ad valorem assessment for the cost of providing beach business improvements services, facilities and programs that have a special benefit to commercial property located within the beach area. The funding proposals are consistent with the legislative determinations of special benefit found in C-06-34, Section 1.04(A)(2), Fort Lauderdale Code of Ordinances, by increasing the number of visitors to the BBID.

Reimbursement of the funds will be contingent upon an executed Grant Participation Agreement (Exhibit 3) with the City. Invoices for reimbursement shall be submitted after event completion documenting the purchase and services before a payment is made.

Resource Impact

There will be a \$75,000 Fiscal Year 2025 impact to the city in the account listed below.
