INTERIM AGREEMENT

BETWEEN

BROWARD COUNTY

And

CITY OF FORT LAUDERDALE

For

COMMUNITY BUS SERVICE

This is an Agreement ("Agreement"), made and entered into by and between: BROWARD COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY,"

and

CITY OF FORT LAUDERDALE, a municipal corporation organized and existing under the laws of the state of Florida, its successors and assigns, hereinafter referred to as "CITY," (collectively referred to as the "Parties").

WITNESSETH:

WHEREAS, the existing Interlocal Agreements for Community Bus Service between the Parties expire on September 30, 2014; and

WHEREAS, the Parties continue to negotiate the terms of new Interim Agreements for the provision of community bus services; and

WHEREAS, the Parties find it to be of great public importance to continue community bus service operations during the interim period until such agreement can be reached; NOW THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, covenants and payments hereinafter set forth, COUNTY and CITY agree as follows:

Section 1. Beginning October 1, 2014 until such time as the Parties execute a new Interlocal Agreement, County will allow City to use the vehicles listed in Exhibit 1, attached hereto and incorporated herein, for Community Bus Service subject to the following:

- (1) City shall provide proof of insurance to County for all vehicles and operations contemplated in this agreement; and
- (2) City shall only seek reimbursement for services rendered under this Interim Agreement once the Interlocal Agreement between the Parties is fully executed; and
- (3) An October 1, 2014 effective date is not disallowed under applicable Federal rules.

Section 2. City will continue operation of Community Bus Services for an interim period beginning October 1, 2014 until such time as the Parties execute a new Interlocal Agreement.

Section 3. The new Interlocal Agreements for community bus services shall have an effective date of October 1, 2014.

Section 4. This Interim Agreement shall automatically terminate effective upon the complete execution of the Parties' new Interlocal Agreements for Community Bus Service. In no event shall this Interim Agreement extend beyond October 31, 2014.
