## **RESOLUTION NO. 13-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, ADDING THE NAME "SISTRUNK BOULEVARD" AS THE SECONDARY STREET NAME TO THAT SECTION OF NE 6<sup>th</sup> STREET FROM NORTH ANDREWS AVENUE TO US-1/FEDERAL HIGHWAY.

WHEREAS, at its meeting on April 25, 2012, the Northwest Progresso–Flagler Heights (NWPFH) Redevelopment Advisory Board requested that the City Commission consider adding the name "Sistrunk Boulevard" as a secondary name to NE 6<sup>th</sup> Street from North Andrews Avenue to US-1/Federal Highway; and

WHEREAS, at its monthly meeting on October 16, 2013, the Flagler Village Civic Association passed a resolution in favor of the addition of the secondary street name; and

WHEREAS, at its meeting on October 17, 2013, the Flagler Village Improvement Association also passed a resolution in favor of the addition of the secondary street name; and

WHEREAS, the request is to honor Dr. James F. Sistrunk, a historical pioneer of the City of Fort Lauderdale who helped establish Provident Hospital and delivered over 6,000 babies throughout his distinguished career;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

- <u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale hereby declares that the name "Sistrunk Boulevard" be added as the secondary street name to that section of NE 6<sup>th</sup> Street from North Andrews Avenue to US-1/Federal Highway.
- <u>SECTION 2</u>. That the City Clerk is directed to provide a copy of this Resolution to the Broward County Traffic Engineer for future inclusion in the "Official Map of the City of Fort Lauderdale."
- <u>SECTION 3</u>. That the City Clerk is directed to provide a copy of this Resolution to the City Engineer for future inclusion in the official map of the City of Fort Lauderdale.
