TITLE: Motion to Approve Three-Year Agreement with LeadsOnline, LLC

Recommendation

It is recommended that the City Commission authorize the Mayor and City Manager to execute a three-year agreement with LeadsOnline, LLC commencing July 11, 2017 and concluding on July 10, 2020.

Background

The Commission approved the purchase of the LeadsOnline software using Trust Funds during the April 17, 2017 regular Commission Meeting. The initial annual subscription fee will be funded from the State Trust Fund and each subsequent year will be budgeted in the Information Technology Service Department’s software Maintenance and Support budget.

LeadsOnline is an investigative tool used by law enforcement; which provides rapid electronic access to transactions from thousands of reporting secondhand dealers such as pawn shops, scrap metal yards, second hand stores, eBay, and Internet drop off stores. LeadsOnline creates a database in which investigators can access information relating to missing/stolen property and suspects via hundreds of millions of records contained in their database. Additionally, the process has no cost to the participating secondhand dealers.

Resource Impact

There will be a fiscal impact to the LETF in the amount of \$24,363 for FY17.
