TITLE: Motion Approving the Not-for-Profit Grant Participation Agreement with Young Men's Christian Association of South Florida, Inc., to Provide a Summer Workforce and College Readiness Workshop Series within the City of Fort Lauderdale – \$51,200 - **(Commission Districts 1, 2, 3 and 4)**

Recommendation

Staff recommends the City Commission approve the Not-for-Profit Grant Participation Agreement, in substantially the form attached, with Young Men's Christian Association of South Florida, Inc. (YMCA), for a total of \$51,200, to provide a summer workforce and college readiness workshop series as part of the implementation of the City's Education Enrichment Program Grant from the Florida Department of Education.

Background

The City has continued to expand workforce development offerings each year through spring and summer career and college readiness programs utilizing CARES Act and education enrichment grant funds received from the State of Florida. This funding builds on the success of the City's summer programs and expands services to include after-school enrichment, workforce exploration and citizenship development.

The City has been awarded a \$350,000 Education Enrichment Program Grant (the "Program") by the Florida Department of Education. The purpose of The Program is to enrich summer programming and expand services to include workforce exploration. Through the Education Enrichment Program Grant, the City, via the YMCA, will provide structured workforce and college and career training in the summer of 2026 that will include two (2) workshop sessions per month, with one (1) session dedicated to career exploration and the other focused on resume and essay writing, civic and community engagement, along with the development of financial literacy and college readiness skills within the underserved community. Additional services will encompass programs centered around dress for success, life skills support and quality assurance, and proper interview etiquette.
