**TITLE**: Motion Approving Revenue-Based Service Agreement for Aquatic Program

Management - Sunrise Middle Pool (Rebid) - Park Swim International, LLC

- Annual Revenue of \$18,000 - (Commission District 1)

### **Recommendation**

Staff recommends the City Commission approve a Revenue-Based Service Agreement, in substantially the form attached, for Aquatic Program Management – Sunrise Middle School with Park Swim International, LLC, for the initial one year period annual revenue amount of \$18,000; and authorize the City Manager to approve three (3) one-year renewal options in the annual revenue amount of \$18,000, for a total contract revenue generating amount of \$72,000.

# **Background**

On July 12, 2023, the Procurement Services Division issued Invitation to Bid, Event No. 141, for Aquatic Program Management - Sunrise Middle Pool (Rebid).

On July 31, 2023, the event closed with a total of one (1) bid submitted.

The bid provided by the sole bidder, Park Swim International, LLC, met the bid requirements and is deemed a responsive and responsible bidder with a minimum annual guarantee (MAG) amount of \$18,000. Staff recommends award to Park Swim International, LLC to provide swim classes, swim team practices, community recreational use and specialty instruction and clinics located at the pool at Sunrise Middle School and to be jointly operated by the School Board of Broward County and the City.

On August 18, 2023, the City received a formal protest from Hammerhead Aquatics. On August 29, 2023, the Chief Procurement Officer conferred with the City Attorney's Office and denied the protest. In response to the denial of the protest, Hammerhead Aquatics submitted a Notice of Appeal to the Chief Procurement Officer to schedule an agenda item for the City Commission to consider the protest. A companion item on the regular agenda (CAM #23-0914) has been scheduled. Staff recommends the City Commission affirms the Chief Procurement Officer's decision to deny the protest.

# **Resource Impact**

There is no current year fiscal impact to the City. Future revenue related to this agreement is contingent upon approval of the FY 2024 Budget by the City Commission.
