Dear Commissioner Rogers,

Our program represented residents of Fort Lauderdale in a law suit against the City filed in 2008 in the Federal District Court for the Southern District of Florida, Case No. 0:10-CV-61122-JIC. The District court granted summary judgment to the City on all counts. An appeal of certain issues was taken to the 11th Circuit Court of Appeals by the law firm of White and Case. That appeal is scheduled for oral argument in September of 2013.

As stated in the letter from White and Case dated April 26, 2013, a copy of which is attached, Legal Aid is not representing the appellants before the 11th Circuit and "the claims pending on appeal do not involve the City's administration of federal grant money."

If the appeal is successful and the case is referred back to the District Court, Legal Aid, and not White and Case, will be representing the plaintiffs before the District Court. As stated in my letter to Mayor Seiler and all City Commissioners dated May 17, 2013, a copy of which is attached, "Legal Aid would be precluded from raising any issues of fraudulent misuse of federal funds in District Court Case No. 0:10-CV-61122-JIC and will not do so." So the issue of fraudulent misuse of federal funds cannot and will not be reasserted in that matter.

I hope this clarifies for you the status of this litigation especially as it applies to the issue of fraudulent misuse of federal funds. I will be happy to answer any further questions you might have.
