STREET CLOSURE EXPLANATION

This year the VPCA wishes to close east bound Broward Boulevard east of NE 15th Avenue and close Victoria Park Road southbound from NE 3rd Court. We will have monitors at NE 15th Avenue and Broward Boulevard, at NE 3rd Court and Victoria Park Road and at NE 1st Street and Victoria Park Road to provide ingress and egress for N. Gordon Residents.

These street closures will allow us to force more visitors into the parking lot at 1512 E. Broward Boulevard, allow those who come to setup better access to the park area without slowing down traffic, and will prevent people from parking in the area of Victoria Park Road south of 3rd Court, thus keeping one complaining neighbor happy.

No area will be totally blocked as a result of these closures and access will be permitted into all neighborhoods.

No parking meters will be blocked so no City revenue will be lost.

I understand that the City of Fort Lauderdale Police Department will determine all security requirements and that EMS is required by City Ordinance to be onsite during all outdoor events.

I understand that the City has a noise ordinance. If at any time during the event it is determined by law enforcement personnel, code enforcement personnel, parks and recreation personnel, or any other city representative that the entertainment or music is causing a noise disturbance, I will be directed to lower the volume to an acceptable level as determined by City staff. If a second noise disturbance arises during the event, I may be directed to shut down the music or entertainment for the remainder of the event. I agree to abide by all provisions of the noise control ordinance and understand that my failure to do so may result in a civil citation, a physical arrest, or the shutting down of the event.
