#### RESOLUTION NO. 14-16

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING SUBMITTAL OF AN APPLICATION TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION FOR A PERPETUAL EASEMENT, OR EASEMENTS, FOR THE PURPOSE OF CONSTRUCTING AND MAINTAINING A BEACH EROSION CONTROL WALL AND PEDESTRIAN BEACH WALKWAY IN FAVOR OF THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION IN BROWARD COUNTY, FLORIDA SHOULD BE DRAWN AND EXECUTED BY THE PROPER CITY OFFICIALS THE CITY OF FORT LAUDERDALE.

WHEREAS, the State of Florida Department of Transportation proposed to construct or improve State Road No. A-1-A, Item/Segment No. 4336884 in Broward County, Florida; and

WHEREAS, it is necessary that an easement across certain lands now owned by the City of Fort Lauderdale, Florida be acquired by the state of Florida Department of Transportation; and

WHEREAS, said use is in the best interest of the City of Fort Lauderdale; and

WHEREAS, the State of Florida Department of Transportation has made application to the City to execute and deliver to the State of Florida Department of

Transportation a perpetual easement, or easements in favor of the State of Florida Department of Transportation for the purpose of constructing and maintaining a beach erosion control wall and pedestrian beach walkway; and said request having been duly considered;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the application of the State of Florida Department of Transportation for a perpetual easement or easements is for transportation purposes which are in the public or community interest and for public welfare; that a perpetual easement, or easements, in favor of the State of Florida Department of Transportation in the City of Fort Lauderdale, Florida should be drawn and executed by the City of Fort Lauderdale and consideration shall be nominal consideration.

SECTION 2. That a certified copy of this Resolution shall be forwarded to the State of Florida Department of Transportation at 3400 West Commercial Boulevard, Fort Lauderdale, Florida, 33309.

SECTION 3. That the office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.
