ORDINANCE NO. C-14-24

AN ORDINANCE VACATING, ABANDONING AND CLOSING THE EASTERN PORTION OF SYLVAN LANE, AS SHOWN ON THE PLAT OF "A RESUBDIVISION OF HARBOR BEACH UNIT ONE", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 19, PAGE 10, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, LOCATED NORTH OF HARBOR BEACH PARKWAY, SOUTH OF HARBOR DRIVE, EAST OF EAST LAKE DRIVE AND WEST OF SEABREEZE BOULEVARD, SUCH LAND BEING LOCATED IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

WHEREAS, the applicant, John T. Loos, applied for the vacation of certain right-of-way as described in Section 1 herein; and

WHEREAS, the Planning and Zoning Board, at its meeting of March 19, 2014 (PZ Case No. V14001), did recommend to the City Commission of the City of Fort Lauderdale ("City Commission") the vacation of the below-described portion of a street subject to conditions; and

WHEREAS, the City Clerk notified the public of a public hearing to be held on Tuesday, May 6, 2013 and Tuesday, May 20, 2013 at 6:00 o'clock P.M. in the City Commission Room, City Hall, Fort Lauderdale, Florida for the purpose of hearing any public comment to the vacation; and

WHEREAS, such public hearing was duly held at the time and place designated and due notice of same was given by publication as is required by law; and

WHEREAS, the City Commission has determined that the application for vacation of right-of-way meets the criteria of Section 47-24.6.A.4 of the Unified Land Development Regulations;

ORDINANCE NO. C-14-24

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the below-described portion of a street is hereby vacated, abandoned, and closed and shall no longer constitute a public right-of-way, subject to the utility easement to be conveyed as provided in Section 2 below, more particularly described in the attached Exhibit "A":

THE EASTERN PORTION OF SYLVAN LANE, AS SHOWN ON THE PLAT OF "A RESUBDIVISION OF HARBOR BEACH UNIT ONE", ACCORDING TO THE PLAT THEREOF, RECORDED IN PLAT BOOK 19, PAGE 10, OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, SUCH LAND BEING LOCATED IN THE CITY OF FORT LAUDERDALE, BROWARD COUNTY, FLORIDA.

Location: North of Harbor Beach Parkway, south of Harbor Drive, east of East Lake Drive and west of Seabreeze Boulevard

<u>SECTION 2</u>. That the applicant shall convey a utility easement as approved by the City Engineer as described in the attached Exhibit "B".

<u>SECTION 3</u>. That a copy of this Ordinance shall be recorded in the Public Records of Broward County by the City Clerk within 30 days from the date of final passage.

<u>SECTION 4</u>. That if any clause, section or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 5</u>. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.

<u>SECTION 6</u>. That this Ordinance shall be in full force and effect on the date a certificate executed by the City Engineer is recorded in the Public Records of Broward County evidencing that all conditions for the vacation have been met.

<u>SECTION 7</u>. Issuance of a development permit by a municipality does not in any way create any right on the part of an applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the municipality for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.

<u>SECTION 8</u>. This approval is conditioned upon the applicant obtaining all other applicable state or federal permits before commencement of the development.
