TITLE: Motion Reappropriating Debt Service Payment to Fiscal Year (FY) 2024

Incentive Accounts - (Commission Districts 2 and 3)

Recommendation

Staff recommends the Community Redevelopment Agency (CRA) Board of Commissioners approve the transfer of Debt Service funds to the existing Northwest-Progresso-Flagler Heights (NPF) CRA FY 2024 Incentive Fund.

Background

At the November 21, 2023 CRA Board meeting, the CRA board provided guidance that \$6,000,000 in unspent remaining FY 2023 CRA funds should be used to reduce the amount of any indebtedness to which increment revenues are pledged. The FY 2024 Adopted Budget included a \$7.5 million transfer to the Tax Increment Bond Fund. Of that amount, staff recommends reducing \$6,000,000 of the budget transfer to allow for additional incentive fund availability.

To comply, staff recommends the CRA Board amend the FY 2024 Operating Budget in the amount of \$6,000,000.
