TITLE: Motion Approving Revised Agreement for the Bayview, Hortt and Riverside

Parks Improvements - Sagaris Corp. - \$1,729,478 - (Commission Districts

1 and 4)

Recommendation

Staff recommends the City Commission approve a revised agreement, in substantially the form attached, with Sagaris Corp. (Sagaris) for the Bayview, Hortt and Riverside Parks Improvements projects in the amount of \$1,729,478.

Background

On May 2, 2023, the City Commission approved an agreement for the Bayview, Hortt and Riverside Parks Improvements (CAM 23-0345). Section 14.6 of the Agreement titled "Time for the City to Approve Extra Work" included a \$25,000 cumulative amount allowance for extra work that may be approved by the City Manager pursuant to a change order submitted to the Public Works Director. However, the solicitation documents published by the City reflected a ten percent (10%) allowance in Section 14.6.

During a post-award review of the Agreement after the City Commission's approval on May 2, 2023, but before the contract was fully executed, City staff discovered Section 14.6 the Commission-approved agreement erroneously reflected a \$25,000 cumulative amount allowance for extra work, rather than the correct 10%. Sagaris is aware of the error and agrees to the revised terms in Section 14.6 of the Agreement.

Staff has corrected this error and is recommending the City Commission reconsider this item and approve the revised agreement with a corrected terms in Section 14.6.

Resource Impact

There is no fiscal impact associated with this action.
