TITLE: Motion to approve a lease agreement

Recommendation

It is recommended that the City Commission authorize the execution of a Lease Agreement for police use.

Background

The City's contracted real estate service, Commercial Real Estate Services (CBRE), has obtained a quote for a leased facility designed to house approximately twenty-five (25) personnel.

The following table is reflective of the proposed lease.

The cost for the first year lease will be \$109,116. Estimated utility cost will be \$10,000. There will also be an IT remote location setup charge of approximately \$31,473.

CBRE, the City's Real Estate Advisor, reports that comparable properties receive \$13-\$14/rsf base rent plus \$10-\$12/rsf in operating expenses and real estate taxes.

Resource Impact

There will be no lease cost this fiscal year as part of the lease agreement. The only cost impact this fiscal year will be for utilities, estimated at \$3,333.00, for the remaining three months. FY 2015 and subsequent lease expenditures are contingent upon approval and appropriation of the annual budgets.
