TITLE: Resolution approving the acceptance of title transfer of seven (7) Sun

Trolley vehicles from Broward County to the City

Recommendation

It is recommended that the City Commission approve a resolution authorizing the City Manager to accept the title transfer of seven (7) trolley vehicles from Broward County.

Background

Broward County Transit (BCT) acquired trolleys through a grant from the Federal Transit Administration (FTA) in 2007. The County is offering to transfer ownership of the vehicles to the City at no cost because the grant project period has ended.

The FTA allows for the transfer of rolling stock from one grantee to another once a vehicle has met its useful life of 7 years/200,000 miles. FTA requires a board resolution from both the transferring grantee's board and the accepting grantee's board to approve the transfer of the vehicles. In accordance with the requirement of FTA Circular 5010.1D, the FTA will retain interest in the vehicles as long as they have a value of over \$5,000 and the City will assume all recording and reporting requirements for the grant that was previously handled by Broward County until such is reached.

Staff will be coming forth on a future agenda with the proposed interlocal agreement between the City and the Downtown Fort Lauderdale Transportation Management Association (TMA) for operating the Sun Trolley service with said vehicles.

The attached spreadsheet illustrates the inventory of the seven (7) County-owned trolleys that will be transferred to the City (Exhibit 1).

Resource Impact

The County is offering to transfer ownership of the vehicles to the City at no cost because the grant project period has ended. The cost to the City will be for the transfer of the vehicle title and tags which is approximately \$751.60, with a cost per vehicle of

\$93.95 (\$86.10 for title and \$7.85 for City Tag Transfer). The TMA will continue to operate and maintain the vehicles in accordance and with FTA requirements, as part of its contract with the City once the interlocal agreement is approved and executed.
