TITLE: Revised PUR-9 Motion to approve purchase of computer software,
hardware and services for Broward County regional consolidated dispatch
and records management systems - \$1,950,371

Recommendation

It is recommended that the City Commission approve the purchase of computer software, hardware, and services to begin the migration into the Broward County regional consolidated dispatch and records management systems, for a total estimated cost of \$1,950,371 utilizing the following vendors, (both proprietary and competitive contracts), and approve agreements in substantially the form attached:

- Police Records and Field Reporting Software - SunGard Public Sector, Inc. – (OSSI – Open Software Solutions Incorporated product line) - Proprietary - \$1,303,382
 - Field Reporting \$1,107,362 (funded from DEA Confiscated Property Trust Funds)
 - Police Records \$196,020
- Computer Aided Dispatch (CAD) Software – Motorola Solutions, Inc. – Proprietary - \$257,832
- Virtual server hardware and software - Computer Systems Support, Inc. (CSS) - State of Florida IT Contract #250-000-09-1 - \$46,804
- Microsoft software licenses – SHI International Corporation - State of Florida IT Contract #252-001-09-1 - \$86,492
 - Microsoft Visio software licenses \$55,114 (funded from DEA Confiscated Property Trust Funds)
 - Microsoft Server software licenses \$31,379
- Disk-based backup hardware – Syscom Technologies, Inc. – GSA (General Services Administration) Schedule 70 Contract #GS-35F-4342D - \$28,031
- Portable printers and swipe card readers – CDW Government LLC (CDW-G) National IPA Tech Solutions Contract #130733 - \$200,629 (funded from State Confiscated Property Trust Funds)
- Mobile equipment installation services – Control Communications Contract #735-11174 - \$27,200

Background

At its September 3, 2013 Regular Meeting (CAM 13-1210, 13-1211, 13-1212), the City Commission approved motions to enter into agreements with Broward County providing for participation in the Consolidated Regional E-911 Communications System.

These purchases are necessary in order to participate in the regional system. Equipment and software associated with field reporting capabilities, which is new technology for the Police Department, will be funded by State Law Enforcement and Drug Enforcement Administration Confiscated Property Funds (as itemized above in the Recommendation) for a total of \$1,363,105. The remaining purchases are being funded from the Central Services Fund balance for a total of \$587,266.

Chief of Police Franklin C. Adderley hereby makes this request of the City Commission for the above-described expenditure of confiscation funds and hereby certifies that the expenditure is for a law enforcement purpose in accordance with F.S. 732.7055 and the federal guidelines set forth in the Guide to Equitable Sharing for State and Local Law Enforcement Agencies (see Exhibit 4).

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,950,371.
