A RESOLUTION OF THE FORT LAUDERDALE COMMUNITY REDEVELOPMENT AGENCY, AMENDING THE COMMUNITY REDEVELOPMENT AGENCY BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016 AND ENDING SEPTEMBER 30, 2017; TRANSFERRING FUNDS BETWEEN CAPITAL PROJECTS AND APPROPRIATING FUND BALANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 12, 2016 the Fort Lauderdale Community Redevelopment Agency adopted the Final Operating Budget, and Capital Improvement Plan (CIP) Allocations for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE FORT LAUDERDALE, COMMUNITY REDEVELOPMENT AGENCY:

SECTION 1. That the Final Operating Budget of the Fort Lauderdale Community Redevelopment Agency for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017 is hereby amended by appropriating funds as set forth in the Community Redevelopment Agency Agenda Memo #17-0475, copy of which is attached hereto and incorporated herein.

SECTION 2. That this Resolution shall be in full force and effect upon final passage.

**Recommendation**

It is recommended that the Community Redevelopment Agency (CRA) Board of Commissioners approve the appropriation of Central Beach FY 2016 unspent funds of \$612,374 and the Re-scope of Aquatics Complex Project (P12315) of \$13,830,837 totaling \$14,443,211 for the Aquatics Complex Renovations; and the appropriation of Northwest Progresso Flagler Heights FY 2016 unspent funds of \$182,115 for the Mizell Center Upgrade Project (P11987).

**Background**

Florida Statutes, Section 163.387(7), requires all unspent funds at the end of the fiscal year be returned to each taxing authority, appropriated to a specific redevelopment project, used to reduce the amount of any indebtedness to which increment revenues are pledged, or deposited into an escrow account for the purpose of later reducing any indebtedness.

The original scope of the New Aquatics Center Parking Garage has changed. The new scope allows the Community Redevelopment Agency to close and transfer all remaining funds from Aquatics Center Parking Garage and Las Olas Dredging Projects to the newly created project, Aquatics Complex Renovations.

- Unique and world renowned in the aquatics field, the Fort Lauderdale Aquatic Complex is a City-owned and operated 5-acre venue comprised of municipal swimming pools and the International Swimming Hall of Fame (ISHOF) museum. Renovation of the existing facility for public use includes the following improvements: remove existing 50 meter competition pool and provide new

expanded fully Federation Internationale De Natation (FINA) compliant pool with moveable bulkheads; remove existing dive pool and provide new expanded FINA compliant pool and dive tower; provide spectator seating for diving and competition pool; remove existing spa for divers and provide new covered spa; expand instructional pool; add new pool deck; remove existing grandstand building; and provide new grandstand with spectator restrooms, concessions, ticket office, and metal bleachers. The City will contribute approximately \$1,200,000 to the project to fund repairs to the existing 50 meter training pool with new surfacing and gutters, and stucco and painting on the existing buildings.

- The Mizell Center Upgrade Project anticipates demolition of the existing Mizell Center located at 1409 Sistrunk Boulevard and the construction of a new 35,000 square feet facility that will welcome a new community facility offering YMCA programs and services, offices and retail space. Preliminary project costs total \$8,000,000. This project was presented to the CRA Board at their meeting on May 17, 2016.

**Resource Impact**

Funds for this transfer in the amount of \$794,489 are available for Fiscal Year 2016 and \$13,830,835 are available for Fiscal Year 2017. Transfer between capital projects and appropriation of unspent funds total \$14,625,326.
