TITLE: Motion to Approve Annual Concrete and Paver Stones Contracts – Team Contracting, Inc. and Weekley Asphalt Paving, Inc. - \$3,200,000

Recommendation

It is recommended that the City Commission award two-year contracts to each Team Contracting, Inc., (Team) and Weekley Asphalt Paving, Inc., (Weekley), in substantially the forms attached, for the annual concrete and paver stones contracts in the total estimated amount of \$3,200,000; and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

Background

On October 6, 2015, the City Commission approved the citywide sidewalk inspection and management system repair priority plan to address approximately 14 percent of the City's damaged sidewalks identified in the damage assessment previously performed by Atkins North America, Inc. The intent of this contract was to begin addressing these damaged sidewalks; however, it will also be utilized to construct improvements in or adjacent to City facilities, and will be a resource for any projects requiring the unit bid items for construction of public improvements. The contractors will receive task orders during the term of the contract. Each task order will be based upon the unit prices indicated in the bid/contract and issued on an as-needed basis.

This is an annual contract without a fixed volume of work. Work will be dependent upon the desire of the City to perform work on a task order basis. Work in the first year will include, but is not limited to, installation of 6-inch thick concrete sidewalks, various curbs, brick pavers, limerock base of various depths, asphaltic concrete, thermoplastic pavement markings, Americans with Disabilities Act (ADA) concrete ramps, removal of asphalt and tree roots, and other items quantified in the proposal pages of this contract.

Invitation to Bid 263-11642 was opened on December 15, 2015 and two bids were received. Staff is recommending award to both contractors, Team and Weekley, based upon the unit prices bid.

Resource Impact

There will be a fiscal impact to the City in the amount of \$3,200,000 for the two contracts.
