Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with Ric-Man Construction Florida, Inc., for the River Oaks Stormwater Improvements Project in the amount of \$25,043,981.79.

Background

The purpose of the described project is to install new stormwater infrastructure, and repair existing stormwater infrastructure within the River Oaks Neighborhood. The objective of proposed project aims to address the flooding concerns in the neighborhood by improving the stormwater collection and conveyance infrastructure. Additionally, the project scope includes neighborhood roadway resurfacing and landscape restoration.

On March 5, 2021, the Procurement Services Division issued Invitation to Bid No.12505-613. The City received seven bids in response to the solicitation which was opened on May 18, 2021. None of the seven vendors were identified as either a Minority Business Enterprise, Women Business Enterprise, or Small Business Enterprise.

The bid submitted by Ric-Man Construction Florida, Inc., has met all the specifications of the solicitation, and is deemed the lowest cost, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact to the City of \$25,043,981.79 for the contract award, with the bid allowances included and \$1,092,000 for estimated in-house project management fees for a total project cost of \$26,135,981.79. Funds for this purchase, in the total amount of \$26,135,981.79, are available in the FY2021 Community Investment Plan in the account listed below.
