

**CITY OF FORT LAUDERDALE
CONSTRUCTION ENGINEERING AND INSPECTION SERVICES AGREEMENT**

THIS CONSTRUCTION ENGINEERING AND INSPECTION SERVICES AGREEMENT ("Agreement") made and entered into this _____ day of _____, 2024, by and between the City of Fort Lauderdale, a Florida municipal corporation ("City") and Solid Consulting Engineers, Inc., a Florida corporation ("Contractor") ("Party" or collectively "Parties");

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of March 8, 2023, authorized by motion to award an Agreement between Contractor and City authorizing the performance of services in connection with the Construction Engineering and Inspection Services for State Road (SR) A1A Streetscape and Lighting Improvements, Request for Qualifications (RFQ) No. 12759-236, Project No. P11681 ("Original Agreement"); and

WHEREAS, due to a three-week work stoppage to allow access for the October 2023 boat show setup and subsequent delays due to two extreme weather events in November 2023 which resulted in several weeks of work stoppage to perform extensive sand cleanup, and local business owners requested a delay of several months to install the bollards on the west side of State Road A1A which was approved by City Management.

WHEREAS, the Original Agreement expired on December 31, 2023; and

WHEREAS, the City and Contractor are desirous of completing the Project.

NOW, THEREFORE, the Parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as follows:

1. The recitations set forth above are true and correct and are incorporated herein. Initial capitalized terms or other such terms used herein shall have the same meaning given such terms in the Original Agreement, unless otherwise defined herein or unless the context otherwise indicates.
2. The Original Agreement and all terms and conditions of the Original Agreement except as modified herein, are incorporated into and made part of this Agreement and are attached hereto as Exhibit A.
3. This Agreement will be retroactive to December 31, 2023.
4. The Contract Time as defined in the Original Agreement shall be understood to also include the period of time from the termination of the Original Agreement to the time of execution of this Agreement.
5. The Notice to Proceed was issued on April 18, 2023 and identified that all Work shall be completed by December 31, 2023, however, Section 1 of the Notice to Proceed is hereby amended as follows: "The Work shall be Substantially Completed within 274 calendar days from December 31, 2023, which is September 30, 2024.
6. Anti-Human Trafficking: As a condition precedent to the effectiveness of this Agreement,

the Contractor shall provide the City with an affidavit signed by an officer or a representative of the Contractor under penalty of perjury attesting that the Contractor does not use coercion for labor or services as defined in Section 787.06, Florida Statutes (2024), as may be amended or revised.

7. Foreign Countries Of Concern: As a condition precedent to the effectiveness of this Agreement, the Contractor shall provide the City with an affidavit signed by an officer or representative of the Contractor under penalty of perjury attesting that the Contractor does not meet any of the criteria in paragraphs (2)(a)-(c) of Section 287.138, Florida Statutes (2024), as may be amended or revised.
