TITLE: Motion to award a contract for Palm Aire Village West entryway

improvements – Invitation to Bid (ITB) 433-11271 - \$115,215

Recommendation

It is recommended that the City Commission award a contract for Palm Aire West entryway improvements to the lowest cost, responsive, and responsible bidder, Hartzell Construction, Inc., in the amount of \$115,215.

Background

The scope of the Palm Aire Village West entryway improvements includes the installation of entryway signs, tiling, milling/paving, stamped asphalt, exterior painting, curbing/drainage features, Polyvinyl Chloride (PVC) fencing, sodding, landscaping and irrigation.

The Procurement Services Division sent an ITB to 4899 vendors and received three responses. Per City Ordinance, a 5% local preference was applied to the bid received by Florida Bridge Builders, Inc., however, Hartzell Construction, Inc. remained the lowest cost, responsive, and responsible bidder in the amount of \$115,215.

Resource Impact

There will be a fiscal impact to the City in the amount of \$115,215 for the contract and \$27,000 for estimated engineering fees for a total cost of \$142,215.
