**TITLE:** Motion to Approve Contract for Purchase of Curb Valves and Corporation  
Stops – A & B Pipe and Supply, Inc. - \$331,700 (estimated two-year total)

---

**Recommendation**

It is recommended that the City Commission approve a two-year contract, in substantially the form attached, with A & B Pipe and Supply, Inc. for the purchase of curb valves and corporation stops in the estimated amount of \$331,700; and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

**Background**

Daily operation and maintenance of the City's 784 miles of water distribution main piping and 62,000 service lines and meters require a constant supply of curb valves and associated repair products. These items include curb valves and corporation stops for the installation of meters and water valves. This contract will be used on an as-needed basis; the cost of the purchases will be charged against individual requisitions to make infrastructure repairs. The initial costs will provide for an adequate supply to be maintained in the City's pipe yard inventory

On April 28, 2017, the Procurement Services Division issued Invitation to Bid No. 472-11941. Three bids were received on May 17, 2017. The bids submitted were reviewed for compliance with the specifications of the solicitation. The bid submitted by A & B Pipe and Supply, Inc. has been deemed the lowest cost, responsive, and responsible bidder recommended for award.

**Resource Impact**

There will be a fiscal impact to the City in the estimated amount of \$100,000 for A&B Pipe and Supply, Inc., and funds are available in the FY 2017 Operating Budget in the accounts listed below. Future year expenditures are contingent upon approval of fiscal year budgets.
