TITLE: Motion Approving Agreement for the Rehabilitation of the SW 2nd Avenue Median Parking Modifications – GPE Engineering & General Contractor Corp. – \$134,418.69 – **(Commission District 4)**

Recommendation

Staff recommends the City Commission approve an agreement, in substantially the form attached, with GPE Engineering & General Contractor Corp. for the rework of the SW 2nd Avenue Median Parking Modifications in an amount not to exceed \$134,418.69.

Background

The SW 2nd Avenue Median Parking Modifications project is located along SW 2nd Avenue between SW 30th Street and SW 32nd Street in the City of Fort Lauderdale. In 2019, the City began a project to develop an existing roadway median into a parking area with 27 parking spaces and raised crosswalks. The project was substantially completed in 2020; however, it was never completed as the City terminated the agreement with Continental Construction USA LLC, the original contractor, for \$263,384.10.

The proposed agreement is to address the deficiencies and complete the project. The work to be accomplished under the proposed agreement includes, but is not limited to, demolition of an existing parking lot and construction of new parking spaces, sidewalk improvements, drainage improvements, and the installation of speed tables to accommodate traffic calming improvements along SW 2nd Avenue.

On March 13, 2022, the Procurement Services Division issued an Invitation to Bid (ITB) No. 12656-1023. During the bidding period no bids were submitted. Thus, the bid due date was extended. A total of two (2) firms responded on May 20, 2022. GPE Engineering & General Contractor Corp. met all of the solicitation requirements of the ITB and deemed the low, responsive, and responsible bidder.

Resource Impact

There will be a fiscal impact to the City in an amount not to exceed \$134,418.69 for the agreement. Funds for proposed agreement are available in the FY 2022 Community Investment Plan in the account(s) listed below.
