

THIRD MUNICIPAL AMENDMENT

to

Comcast Enterprise Services Master Services Agreement No. FI-25848367-DIngb

This Third Municipal Amendment (“Third Amendment”), effective upon execution of all parties below (“Effective Date”), is entered into by and between Comcast Cable Communications Management, LLC (“Comcast”) and City of Fort Lauderdale (“Customer”), individually referred to herein as “Party” and jointly referred to as “Parties”.

Whereas, the Parties desire to amend the Agreement by this Third Amendment to reflect the amended or additional terms and conditions to which the Parties have agreed to.

Now, therefore, in consideration of the mutual covenants, promises, and consideration set forth in this Amendment, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Capitalized terms used and not defined in this Third Amendment have the respective meanings assigned to them in the Agreement.
2. Customer certifies that its use of the Comcast Enterprise Ethernet Transport Services (the “Metro Ethernet Transport Services”) is such that ten percent (10%) or less of the traffic is jurisdictionally interstate according to FCC regulations. More specifically, Customer certifies that ten percent (10%) or less of the traffic carried on the Metro Ethernet Transport Services is ultimately bound for (i) the Internet or (ii) a location outside the state.
 - a. In making this certification, Customer may rely on traffic studies or measurements. Where such type of data is not available, Customer may rely on factors, such as the design of its network or the nature of its communications needs, that are reasonably likely to enable Customer to make a good faith approximation of its relative intrastate and interstate traffic volumes.
 - b. Upon request, Customer agrees promptly to provide Comcast with documentation that explains the methodology that Customer used to determine or make a good faith approximation of its relative intrastate and interstate traffic volumes. Customer also agrees to promptly provide such other assistance as Comcast may request to respond to an inquiry from a government authority or its agent regarding the classification of Customer’s traffic, including the appropriate treatment of the traffic under the Federal Communications Commission’s Universal Service Program.
 - c. Customer agrees, to the extent permitted by law and up to the limits in Sec. 768.28, Florida Statutes, to defend, indemnify and hold harmless Comcast from and against any claims, liabilities, damages and expenses, including reasonable attorneys’ and other professionals’ fees, arising out of or relating to any violation of Comcast’s Universal Service Program contribution requirements or other FCC or other legal or regulatory requirements relating to Customer’s certification regarding its use of the Metro Ethernet Transport Services. Nothing in the Master Services Agreement and any amendments thereto, shall be construed as a modification, compromise, or waiver by Customer of any immunities afforded to it under applicable law or any limits of liability afforded to it by applicable law, including Sec. 768.28, Florida Statutes, with respect to matters arising out of the Master Agreement and any amendments thereto.

3. Customer agrees to provide Comcast with documentation in support of this certification as may be needed by Comcast to respond to an inquiry from a government authority or its agent regarding the proper classification and assessment of these services.
4. As of the Effective Date set forth herein, the Ethernet Private Line Services and Ethernet Network Services set forth in Sales Order No. FI-25848367-DIngb-25580638 are modified to reflect an intrastate Services jurisdiction. Any and all future Sales Order(s) duly executed under the Agreement shall specify the applicable Services jurisdiction therein. Except to the extent Customer has provided a valid tax exemption certificate in accordance with Section 3.1(C) of the Comcast Enterprise Services General Terms and Conditions, Customer agrees to pay all applicable federal, state and local taxes, surcharges and fees that are effective or become effective during the term of the Agreement that are applicable to Comcast intrastate Enterprise Metro Ethernet Transport Services.
5. Intrastate Services are provided by Comcast Phone of Florida, LLC.
6. In the event of an explicit conflict between this Third Amendment and the Agreement, the provisions, terms and conditions of this Third Amendment shall take precedence in the interpretation of the explicit matter in question.
7. Except as otherwise modified by this Third Amendment, all other provisions, terms and conditions set forth in the Agreement shall remain in full force and effect.

Unless otherwise indicated herein, capitalized words shall have the same meaning as in the Agreement.

By purchasing Comcast voice services, you are giving Comcast Business permission to request a copy of the Customer Service Record(s) from your existing carrier(s). Customer Service Records include the telephone numbers listed on the account(s) and may also include information related to services provided by such carrier(s).

COMPANY ACKNOWLEDGES RECEIPT AND UNDERSTANDING OF THIS 911 NOTICE:

Your Comcast Business Voice Services set forth in this Sales Order (the "Voice Services") have the following 911 limitations:

- In order for 911 calls to be properly directed to emergency services using the Voice Services, Customer must provide and maintain the correct service address information ("Registered Service Location") for each telephone number and extension used by Customer. The Registered Service Location should also include information such as floor and office number as appropriate.
- If the Voice Services are moved to, or used in, a different location without Customer providing an updated Registered Service Location, 911 calls may be directed to the wrong emergency authority, may transmit the wrong address, and/or the Voice Services (including 911) may fail altogether. Customer's use of a telephone number not associated with its geographic location, or a failure to allot sufficient time for a Registered Service Location change to be processed, may increase these risks.
