**Recommendation**

It is recommended that the City Commission approve Work Authorization No. 4 in the amount of \$67,862.00 under the Annual Utilities Restoration Contract with Molloy Bros. Inc., Project 11857.

**Background**

In compliance with Section 2-179 (5) of the City Code of Ordinances, all work orders under any annual contract in a cumulative amount over \$25,000.00 must be brought back to the City Commission for approval.

The Annual Utilities Restoration Contract provides the City with the ability to complete utility system repairs that are beyond the capability or capacity of City crews and equipment. The contract was renewed by the City Commission on August 20<sup>th</sup>, 2013, in the not to exceed amount of \$749,830.00. Work orders are assigned only on an as-needed, per available funds. The contract sum is not a guarantee of the amount of work that will be issued.

Work Order No. 4 encompasses three (3) locations. The work is for: 1) construction of a new six (6) inch sanitary sewer lateral (425 Southwest 4th Avenue), 2) point repair to a ten (10) inch gravity main (Southeast 3rd Avenue), and 3) construction of new 6 inch sewer lateral for new townhouse construction (2727 NE 14 St). Please note, work includes excavation, backfilling, roadway restoration (including full lane asphalt milling and resurfacing), and site restoration of curbs, gutter, and sidewalk, and sod.

**ResourceImpact**

There is a fiscal impact to the City in the amount of \$67,862.00 for Work Order No. 4, and \$11,536.54 for associated, engineering fees.
