**TITLE:** Motion approving Grant Agreement Broward County, Land Stewardship  
Program, Parks for People Grant, Lewis Landing, \$75,000 City Match  
Required.

**Recommendation**

It is recommended that the City Commission approve a motion authorizing the proper city officials to execute a Grant Agreement with Broward County. Land Stewardship Program, Parks for People Grant, Lewis Landing in the amount of \$75,000.

**Background**

On October 26, 2012, the Parks and Recreation Department submitted a Parks for People grant application to Broward County. Funds will be used to incorporate “green” amenities into the development of the site, namely towards the purchase and installation of solar lighting and a pervious pathway. The City’s cost share is a match amount that is represented in the 5 year Capital Improvement Plan allocation for the project site, equivalent to the applicant's funded grant amount.

Grant funds are available for sites that were acquired through the 2000 Safe Parks and Land Preservation Bond Program; it is a supplemental grant to incorporate “green” standards in the development of bond acquired green space and open space sites. Green standards include features or amenities composed of recycled materials or environmentally sound components.

In January of 2013, staff received notification from Broward County acknowledging approval of the grant in the amount of \$75,000. The Grant period will be twelve (12) months from the date of execution.

**Resource Impact**

There is a positive impact to the City in the amount of \$75,000. Matching funds in the amount of \$75,000 have been identified in existing capital funded projects. Funds are being appropriated through companion item #13-0688.
