TITLE: Motion Approving a Parking Enforcement Agreement with First
Presbyterian Church of Fort Lauderdale, Florida, Inc., Located at 401 SE
15th Avenue – **(Commission District 4)**

Recommendation

Staff recommends the City Commission approve a motion authorizing the City Manager to execute a three-year parking enforcement agreement, substantially in the form attached, with First Presbyterian Church of Fort Lauderdale, Florida, Inc., to monitor and enforce parking on five (5) parcels located at the corner of East Las Olas Boulevard and Tarpon Drive.

Background

The proposed agreement provides the City the ability to perform parking enforcement services for the First Presbyterian Church on five (5) parcels located at the corner of East Las Olas Boulevard and Tarpon Drive that will be made available for public parking. The enforcement services provided by the City since 2018 will promote public safety for the parking lot patrons and will serve as a legitimate municipal purpose.

This proposed agreement will be for a period of three (3) years. The City will enforce all City parking ordinances within these lots pursuant to Chapter 26 of the Code of Ordinances of the City of Fort Lauderdale and in accordance with the terms and conditions set forth in this agreement. The City shall retain all citation revenue derived by parking enforcement actions.

Resource Impact

There will be a positive fiscal impact associated with the agreement for any citation revenue generated.
