## EXTENSION TO INSTRUCTOR AGREEMENT

THIS IS AN EXTENSION TO THE INSTRUCTOR AGREEMENT made and entered into this 3rd day of September, 2013, by and between:

CITY OF FORT LAUDERDALE, a municipal corporation of the State of Florida, hereinafter referred to as "City",

and

PARTNERS IN ACTION, INC., a Florida non-profit corporation d/b/a Kids Ecology Corps., hereinafter referred to as "Instructor",

WHEREAS, City and Instructor entered into a certain Instructor Agreement for Instructor to conduct nature programming lessons at Snyder Park for an initial term of one (1) year beginning September 15, 2010 and ending September 14, 2011 ("Instructor Agreement"); and

WHEREAS, pursuant to Section 3 of the Instructor Agreement, the City has the option to extend the term of the Instructor Agreement for three additional one-year terms; and

WHEREAS, the parties have exercised the first extension option; and

WHEREAS, the parties entered into a Second Extension and Amendment; and

WHEREAS, the parties now desire to exercise the third option to extend the term of the Instructor Agreement for an additional one year term; and

WHEREAS, pursuant to Motion, adopted at its meeting of September 3, 2013, the City Commission authorized the extension of the Instructor Agreement for an additional one year term; and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth below, and other good and valuable considerations, the receipt and adequacy of which are hereby acknowledge, the parties agree as follows:

1. The foregoing recitals are true and correct and incorporated herein by reference.
2. Pursuant to Section 3 of the Instructor Agreement, the term of the Instructor Agreement is hereby extended for an additional one year term beginning September 15, 2013 and ending September 14, 2014.
3. All other terms and provisions of the original Instructor Agreement as amended between the parties are hereby ratified, reaffirmed and shall remain in full force and effect.
