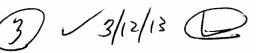

## THIRD EXTENSION TO AGREEMENT

CITY OF FORT LAUDERDALE, a municipal Corporation of the State of Florida, (hereinafter referred to as "CITY")

and

URS Corporation Southern, a California Corporation authorized to do business in the State of Florida, (hereinafter referred to as "CONSULTANT").

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of June 2, 2009, authorized the proper officials by motion to execute an Agreement between CONSULTANT and CITY authorizing the performance of services in connection with Agreement, 696-10129 Coastal Engineering Consultant Services (the "Agreement"); and

WHEREAS, Section 6.1 of the Agreement authorizes renewal for three (3) successive one (1) year terms upon mutual consent of the parties; and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of February 15, 2011, authorized the proper officials by motion to execute a First Extension to Agreement between CONSULTANT and CITY authorizing the performance of services until July 27, 2012; and

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida at its meeting of May 1, 2012, authorized the proper officials by motion to execute a Second Extension and Amendment to Agreement between CONSULTANT and CITY authorizing the performance of services until July 27, 2013; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted professional consultant services to CITY until July 27, 2014, utilizing the contract prices of the original Agreement; and

WHEREAS, at its meeting of <u>March</u> 5, 2013, the City Commission, by motion, authorized the proper City Officials to execute this Third Extension to Agreement;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

- <u>Section 1</u>. The foregoing recitals are true and correct and are made a part of this Third Extension to Agreement.
- <u>Section 2</u>. That the Agreement between CITY and CONSULTANT approved by the City Commission on June 2, 2009 is hereby extended said term expiring on July 27, 2014.

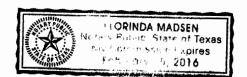
