**AGREEMENT FOR UNDERCOVER VEHICLE RENTAL SERVICES BETWEEN THE CITY OF  
FORT LAUDERDALE AND 2<sup>ND</sup> CHANCE HOLDINGS, INC., D/B/A BUDGET CAR RENTAL**

THIS AGREEMENT, made and entered into this 1<sup>st</sup> day of November, 2013, is by and between the City of Fort Lauderdale, a Florida municipality, ("City"), whose address is 100 North Andrews Avenue, Fort Lauderdale, FL 33301-1016, and 2<sup>nd</sup> Chance Holdings, Inc., a Florida corporation doing business as Budget Car Rental, ("Contractor" or "Successful Proposer"), whose address is 7944 Pines Blvd., Pembroke Pines, FL 33024.

WHEREAS, the City and the Contractor wish to enter into an agreement for undercover vehicle rental services based on an agreement between the Contractor and the City of Coral Springs, a Florida municipality, via a cooperative purchasing plan with the Southeast Florida Governmental Purchasing Cooperative Group,

NOW THEREFORE, for and in consideration of the mutual promises and covenants set forth herein and other good and valuable consideration, the City and the Contractor covenant and agree as follows:

1. The Contractor agrees to provide to the City undercover vehicle rental services in accordance with the terms of City of Coral Springs Agreement Number 13-C-103, including City of Coral Springs Request for Proposals No. 13-C-103 ("RFP") and the Contractor's response to the Request for Proposals, (collectively, "Coral Springs Agreement").
2. Except as applied to the proposal evaluation process, the terms "City of Coral Springs," "CITY," or "City," as set forth in the Coral Springs Agreement, mean the City of Fort Lauderdale.
3. Section 28 of the Coral Springs Agreement is amended so that notice is provided as follows:


5. Contractor shall maintain the vehicles subject to this Agreement as provided in the Contractor's response to the RFP.






