The CITY, Aquatic Complex staff and its teams will work with YMCA of the USA to ensure the smoothest even operation as possible. This may require the use of a third competition course for swimming should the event time-line prove too burdensome, as mutually agreed upon by CITY and the YMCA of the USA in advance. Modifications can be made to the proposed competition schedule for operational and functionality purposes.

SWIMMING: Practice for swimming will be available beginning on Wednesday, April 18, 2018 from 8:00 a.m. to 7:30 p.m. Up to eight (8) lanes will be made available in the main competition pool for swimming. The YMCA will be charged a rate of \$8/swimmer Wednesday, April 18, 2018. The main competition pool, warm up pool will be open from 6:00 a.m. until thirty (30) minutes past the end of each competition session from Thursday, April 19 through Sunday, April 22, 2018.

DIVING: Official practice for diving will be available beginning on Thursday, April 19, 2018 from 8:00 a.m. to 7:30 p.m. The dive well will be open from 7:00 a.m. until 2 hours (120) minutes past the end of each competition session Friday, April 19 and Saturday, April 21, 2018.

INSURANCE: Policy effective dates shall be April 18-22, 2018. Additional days may be added to the policy to allow any set-up, staff and volunteer arrivals in advance of the event dates.
