Notice of Funding Availability for State Housing Initiatives Partnership (SHIP) Funds

The City of Fort Lauderdale has received \$64,947.00 in FY 2012-2013 SHIP Funds. These Funds must be used in accordance with the 2012-2013 approved Local Housing Plan.

The City proposes to use these funds as follows:

- Administration - \$6,494.70
- Single Family Housing Rehabilitation - \$58,452.30

We anticipate this funding to assist up to two (2) single-family homes with rehabilitation.

SHIP Rules (F.A.C. 67-37.005) requires that funds must be advertised at least 30 days prior to taking applications. Applications for assistance using these funds will be taken 30 days after this notification. (February 22, 2013)
