Recommendation

It is recommended that the City Commission approve, the 2020-2021 Annual Action Plan and authorize the City Manager to execute the necessary documents associated with each pan for submittal to the U.S. Department of Housing and Urban Development ("HUD").

Background

Annually, the City is required to submit an action plan associated with the consolidated plan. The consolidated plan provides a comprehensive strategy of how the City will use entitlement funding to address housing, economic, and community development needs. The annual action plan identifies specific activities that will be undertaken with federal entitlement funding in each fiscal year to achieve the goals established in the consolidated plan.

The annual action planning process serves as the framework that has been established based on community-wide dialogues. These dialogues identify housing and community development priorities that align with the City's comprehensive plan and support the HUD national objective for: Community Development Block Grant (CDBG), Housing Opportunities for Persons with AIDS (HOPWA), and HOME Investment Partnerships (HOME) Program.

The Proposed 2020-2021 Annual Action Plan (Exhibit 1) provides details on the activities to be undertaken with each grant source and the community agencies that are funded to carry out each activity.

Additionally, the waivers and flexibilities provided under the Coronavirus Aid, Relief, & Economic Security Act (CARES Act) are applicable to Fiscal Year 2020-2021. The City has notified HUD of its intent to utilize these waivers and subsequently utilized the minimum 5-day comment period by placing a public notice and allowing for a 7-day comment period. There were no written comments received during the comment period.
