**TITLE:** Motion to approve the award of South Middle River Neighborhood  
Improvements, Northwest 14<sup>th</sup> Street, from Powerline Road to Andrews  
Avenue – Invitation to Bid (ITB) 943-11335 - \$724,595.71

---

**Recommendation**

It is recommended that the City Commission approve the award of South Middle River Neighborhood Improvements, Northwest 14<sup>th</sup> Street, from Powerline Road to Andrews Avenue, to the lowest cost, responsive and responsible bidder, FHP Tectonics Corp, Inc., in the amount of \$724,595.71 (Base Bid plus Alt.1).

**Background**

The scope of the project for the base bid includes removing existing excess pavement and impervious area and construction of one-way roadways along Northwest 14<sup>th</sup> Streets in the South Middle River Neighborhood. This work includes clearing and grubbing, asphalt removal, concrete removal, gravel removal, tree removal/relocation, storm drainage removal, asphalt pavement installation, milling and resurfacing, concrete pavement installation, curb installation, curb ramp installation, concrete apron installation, storm drainage installation, pavement marking and signage, erosion control and Best Management Practices (BMP's) installation and maintenance, landscape installation, bioswales and solar pedestrian lighting. The alternate bid includes a decorative traffic sign post and two (2) decorative street name signs.

The Procurement Services Division sent an Invitation to Bid (ITB) to seventy nine (79) vendors and received eight (8) responses. It was declared after staff performed due diligence that FHP Tectonics Corp., Inc. is the lowest cost, responsive and responsible bidder in the amount of \$724,595.71.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$724,595.71 for the contract and \$86,951.49 for estimated engineering fees for a total cost of \$811,547.20.
