TITLE: Resolution Authorizing Acceptance of a Drainage Easement with SHM

LMC, LLC - River Oaks Neighborhood Stormwater Improvements -

(Commission District 4)

Recommendation

Staff recommends the City Commission accept a drainage easement with SHM LMC, LLC, in substantially the form attached hereto, for the purpose of maintaining existing stormwater infrastructure and landscaping within the Coconut Canal between SW 20 Street and the New River.

Background

On September 9, 2021, the City Commission awarded a construction agreement to Ric-Man in the amount of \$25,043,981.79 for construction of the River Oaks Stormwater Improvements Project (CAM #21-0803). The project consisted of stormwater infrastructure installation, utility relocation/installation, swale reconstruction, and pavement restoration.

To ensure the newly constructed stormwater infrastructure can properly convey the stormwater runoff to the South Fork of the New River, SHM LMC, LLC has agreed to grant a drainage easement in favor of the City to allow for canal maintenance. The proposed drainage easement is further described in Exhibit 1.

The proposed drainage easement over the Coconut Canal provides the City Fort Lauderdale with access rights to maintain and dredge the canal for conveyance purposes including any emergency response needs. The City plans to dredge the canal in Fiscal Year 2030 and has incorporated \$2.9 million for this purpose in the Community Investment Plan (CIP).

Resource Impact

There will be no fiscal impact to the City associated with this item.
