

RESOLUTION NO. 26-95

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A DISTRICT FOUR MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION, FOR LIGHTING IMPROVEMENTS WITHIN THE RIGHT-OF-WAY OF STATE ROAD 811/NORTHEAST 4th AVENUE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale ("City") wishes to enter into a Florida Department of Transportation District Four Maintenance Memorandum of Agreement ("MMOA") with the Florida Department of Transportation ("FDOT"), for lighting improvements within the right-of-way of State Road 811/Northeast 4th Avenue; and

WHEREAS, because State Road 811 is an FDOT right-of-way, authorization for this work must be permitted by FDOT; and

WHEREAS, FDOT requires municipalities to maintain any non-standard features installed within state rights-of-way, including decorative light poles, as these elements are outside of FDOT's standard treatments; and

WHEREAS, the MOOA formalizes the City's maintenance responsibilities for the installation of non-standard decorative lighting improvements, pursuant to a State of Florida Department of Transportation Construction Agreement No.: 2025-C-491-00009, on State Road 811/Northeast 4th Avenue from State Road 838/Sunrise Boulevard to north of NE 13th Street;


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Commission of the City of Fort Lauderdale, Florida, hereby approves a District Four Maintenance Memorandum of Agreement with the Florida Department of Transportation, for lighting improvements within the right-of-way of State Road 811/Northeast 4th Avenue.

SECTION 2. That the office of the City Attorney shall review and approve as to form all documents prior to their execution.


SECTION 3. That this Resolution shall be in full force and effect upon final adoption.
