TITLE: Motion Approving a Piggyback Agreement with FG Construction, LLC
utilizing the Broward County Contract for Bridges, Structures and
Miscellaneous Roadway Construction (Emergency Disaster/Urgent
Purposes) - \$38,313,605.50 - (**Commission Districts 1, 2, 3 and 4**)

Recommendation

Staff recommends the City Commission approve a piggyback agreement, in substantially the form attached, for Bridges, Structures and Miscellaneous Roadway Construction services utilizing (“piggybacking”) the Broward County (BC) Invitation to Bid No. PNC2127485B1 and resulting contract with FG Construction, LLC (FG) effective through the initial two (2) year term ending July 11, 2026, in the aggregate amount of \$38,313,605.50, and authorize the City Manager to approve three (3) one-year renewal options, for an estimated annual renewal amount of \$19,156,802.75, for a potential total contract amount of \$95,784,013.75, subject to any renewals and extensions by BC and contingent upon appropriation of funds.

Background

The City is responsible for the maintenance and repair of roads, bridges, water and wastewater control structures, and stormwater infrastructure.

The BC agreement with FG includes services that the City would need for the inspection, repair, and/or reconstruction of the City’s road, bridge, utility and stormwater infrastructure in the event of an emergency or disaster event.

Pursuant to Section 2-181(f)(5)(b), Code of Ordinances of the City of Fort Lauderdale, Florida, *“The city may purchase from (piggyback) a contract entered into by another governmental or public entity and a provider of supplies or services required by the city, if the chief procurement officer determines that it is practicable and advantageous for the city to employ this method of procurement.”*

The Chief Procurement Officer has determined that it would be practicable and advantageous for the City to use the proposed method of procurement for this proposed

agreement and will be entered into and utilized in accordance with Bid No. PNC2127485B1 – BC Bridges, Structures and Miscellaneous Roadway Construction with FG.

Resource Impact

There is no current fiscal impact associated with this action. This agreement will only be activated in the event of a qualifying disaster or emergency. This item is contingent upon the approval and appropriation of the annual budget.

Strategic Connections

This item is a 2024 *Commission Priority*, advancing the Public Safety initiative.

- Goal 4. Coordinate with related partners and agencies (at city, local, county, regional, state, and federal levels) to plan for disaster and emergency management, further the resiliency of coastal area, and ensure city-wide community health and public safety.
