Before receiving final approval from the City Commission, I understand that I (and the production company, if applicable) must furnish an original certificate of General Liability insurance naming the City of Fort Lauderdale as additionally insured in the amount of at least one million dollars (\$1,000,000) or greater as deemed satisfactory by the City Risk Manager, and an original certificate of liquor liability insurance in the amount of \$500,000 if alcohol is being served.

I understand that a Parks and Recreation sponsored activity has precedence over the above schedule and I will be notified if any conflicts arise.

I understand that the City of Fort Lauderdale Police Department will determine all security requirements and that EMS is required by City Ordinance to be onsite during all outdoor events.

I understand that the City has a noise ordinance. If at any time during the event it is determined by law enforcement personnel, code enforcement personnel, parks and recreation personnel, or any other city representative that the entertainment or music is causing a noise disturbance, I will be directed to lower the volume to an acceptable level as determined by City staff. If a second noise disturbance arises during the event, I may be directed to shut down the music or entertainment for the remainder of the event. I agree to abide by all provisions of the noise control ordinance and understand that my failure to do so may result in a civil citation, a physical arrest, or the shutting down of the event.

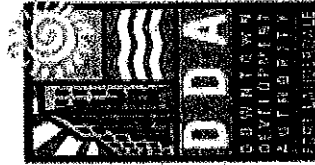

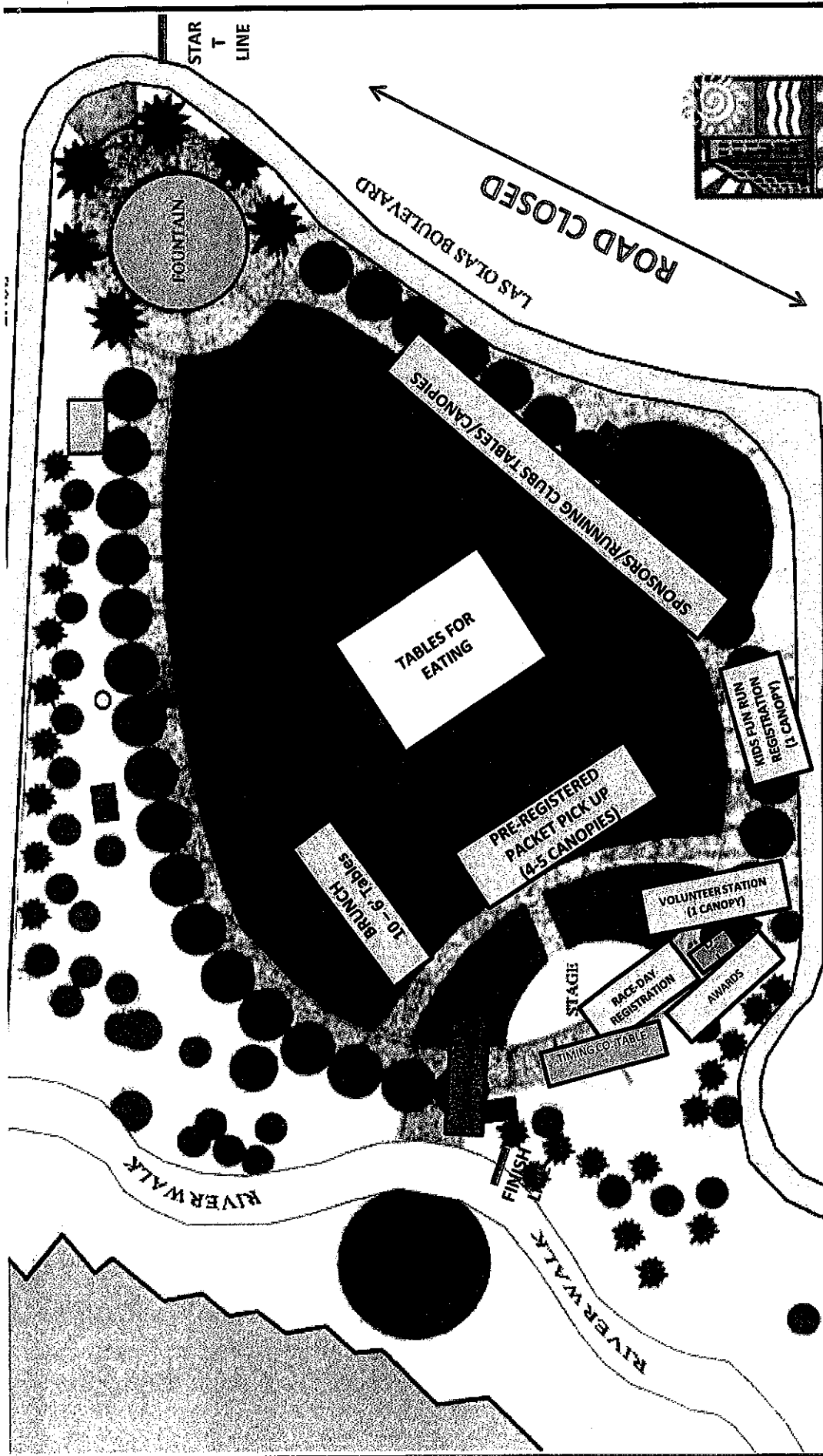

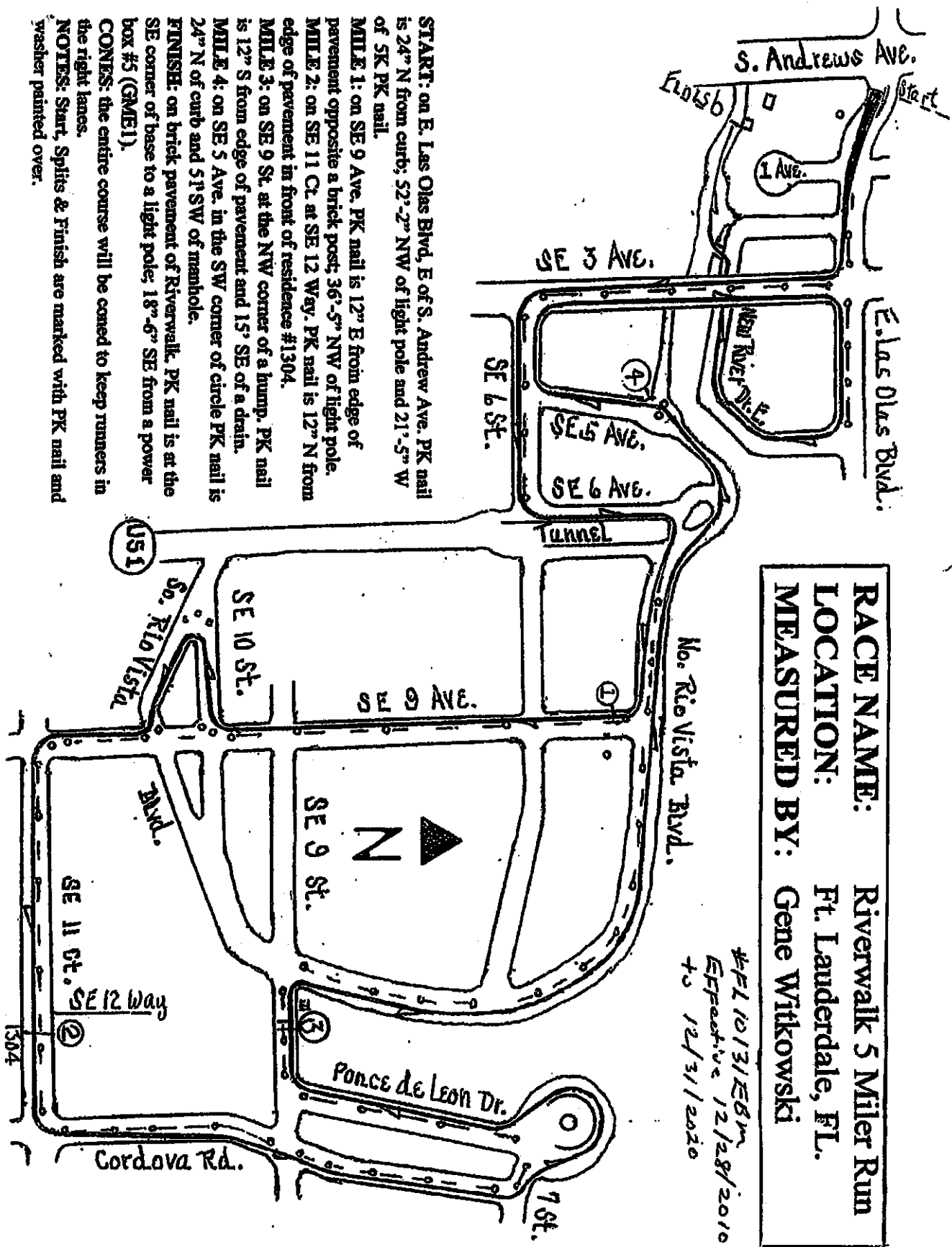

START: on E. Las Olas Blvd, E of S. Andrew Ave. PK nail is 24" N from curb; 52'-2" NW of light pole and 21'-5" W of 5K PK nail.

MILE 1: on SE 9 Ave. PK nail is 12" E from edge of pavement opposite a brick post; 36'-5" NW of light pole.

MILE 2: on SE 11 Ct. at SE 12 Way. PK nail is 12" N from edge of pavement in front of residence #1304.

MILE 3: on SE 9 St. at the NW corner of a hump. PK nail is 12" S from edge of pavement and 15' SE of a drain.

MILE 4: on SE 5 Ave. in the SW corner of circle PK nail is 24" N of curb and 51" SW of manhole.

FINISH: on brick pavement of Riverwalk. PK nail is at the SE corner of base to a light pole; 18'-6" SE from a power box #5 (GME1).

CONES: the entire course will be coned to keep runners in the right lanes.

NOTES: Start, Splits & Finish are marked with PK nail and washer painted over.
