Stormwater Improvements Project - Calvin, Giordano & Associates, Inc. -
\$153,229 Task Order

Recommendation

It is recommended that the City Commission approve a Task Order with Calvin, Giordano & Associates, Inc. (Consultant Services Contract 626-10881-4) for civil engineering services to address stormwater drainage and flooding issues along the Bayshore Drive, Vistamar Street, and Terramar Streets in the Central Beach Alliance Neighborhood in the amount of \$153,229.

Background

On September 10, 2014 the City Commission adopted the five-year Community Investment Plan (CIP) and appropriated funding for Fiscal Year 2015 CIP projects (CAM 14-1326). Project 12065 is included in the Fiscal Year 2015 CIP for the design of stormwater improvements in the Central Beach Alliance Neighborhood.

Due to insufficient drainage infrastructure and tidal influence, flooding and ponding is currently impacting public and private property in the above mentioned areas. The proposed task order provides engineering services for the design of a new drainage system to address these stormwater issues.

The proposed drainage system will improve water quality, reduce water in the right-of-way (ROW), and reduce tidal and storm flooding which is currently damaging public and private property by designing an adequate drainage system. This project is included in Phase I of the Stormwater Master Plan and encompasses the ROW and street along Bayshore Drive, Vistamar Street, and Terramar Street.

Resource Impact

There is a fiscal impact to the City in the amount of \$133,229 for the Task Order and \$20,000 for in house project management fees, for a total of \$153,229.
