

RESOLUTION NO. 26-30

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING AN AMENDMENT TO THE COORDINATED OPIOID RECOVERY PROGRAM SERVICES AGREEMENT WITH BROWARD BEHAVIORAL HEALTH COALITION, INC., AUTHORIZING THE ACCEPTANCE OF ADDITIONAL GRANT FUNDS FROM BROWARD BEHAVIORAL HEALTH COALITION, INC. IN THE AMOUNT OF \$375,000.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH BROWARD BEHAVIORAL HEALTH COALITION, INC. TO ACCEPT SUCH GRANT FUNDING; AND PROVIDING FOR CONFLICTS AND AN EFFECTIVE DATE.

WHEREAS, on July 2, 2024, the City Commission of the City of Fort Lauderdale, Florida, ("City") approved the Coordinated Opioid Recovery Program Services Agreement with Broward Behavioral Health Coalition ("BBHC"), and authorized the acceptance of grant funds in the amount of \$500,000.00, to fund the City of Fort Lauderdale Fire Rescue Department's ("FLFR") Coordinated Opioid Recovery ("CORE") Network of Addiction Care program; and

WHEREAS, the grant funding has provided the department with the ability to purchase a vehicle and hire a full-time Community Health Coordinator; and

WHEREAS, the department has developed protocols and is currently coordinating with partnering organizations to implement the program framework; and

WHEREAS, in 2024, the FLFR responded to 648 opioid related incidents, and in 2025, the FLFR had responded to 500 such incidents; and

WHEREAS, FLFR continues to collaborate and partner with community organizations through the Mobile Integrated Health ("MIH") program to support populations most affected by substance abuse; and

WHEREAS, the City Commission wishes to enter into an amendment to the Coordinated Opioid Recovery Program Services Agreement to update the Deliverables and the Rate Schedule, and to reflect the increase in grant funding provided by BBHC; and

WHEREAS, the City Commission finds that authorizing the execution of the amendment to the Coordinated Opioid Recovery Program Services Agreement and acceptance of the additional grant funds is in the best interest of the City of Fort Lauderdale.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the City Manager is hereby authorized to accept additional grant funds on behalf of the City of Fort Lauderdale from Broward Behavioral Health Coalition, Inc. in the amount of Three Hundred Seventy-Five Thousand and 00/100 Dollars (\$375,000.00) for the Coordinated Opioid Recovery Network of Addiction Care Program.

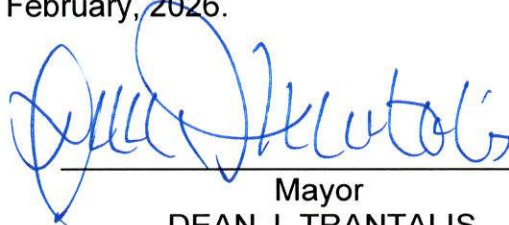
