funds. - Request for Proposal (RFP) 135-11275, \$1,300,000

Recommendation

It is recommended that the City Commission approve a motion to award Community Housing Development Organization (CHDO) funds in the amount of \$1,300,000, for the Home Investment Partnerships (HOME) Program, and authorize the City Manager to execute the documents associated with the funding requests for each agency.

Background

A CHDO is a private nonprofit, community-based service organization whose primary purpose is to provide and develop decent, affordable housing for the community it serves. These funds need to be encumbered immediately to meet the City's commitment for the HOME Program funds by October 30, 2013.

The federal HOME program regulations require each City receiving these funds to set aside at least 15% of its annual allocation of HOME funds for use by CHDO's for the development of affordable housing. The \$1,300,000 consists of HOME funds from 2009 – 2013 and approximately \$662,000 in HOME funds that were repaid to the City's HOME line-of-credit account at the United States Department of Housing and Urban Development (HUD). These funds are to be used to foster partnerships with non-profit providers of affordable housing and banks.

The CHDO RFP was released on August 9, 2013 and the bid process closed on September 3, 2013.

Fort Lauderdale Community Development Corporation (FLCDC) proposes to acquire, rehabilitate and resell four abandoned and / or foreclosed single family residential properties for qualified first time homebuyers.

H.O.M.E.S., Inc. proposes to purchase and rehabilitate four housing units for the purpose of leasing those units to very low and low income families.

Tayan Alliances, Inc. proposes to acquire, rehabilitate and resell one single family residential property for a qualified first time homebuyer.

The proposals were reviewed by the CHDO Evaluation Committee on September 12, 2013. The selection committee included Avis Wilkinson, Administrative Assistant II, Housing and Community Development, Department of Sustainable Development (DSD); Diana McDowell, Administrative Assistant II, Executive Airport, Transportation and Mobility; Bob Wojcik, Planner III, Community Redevelopment, DSD; and David Harvey, Administrative Assistant I, Housing and Community Development, DSD.
