TITLE: Resolution Approving the Execution and Acceptance of the Florida Recreation Development Assistance Program Grant Agreement for Carter Park, in the amount of \$170,000 – (**Commission District 3**)

Recommendation

Staff recommends the City Commission adopt a resolution to accept a grant in the amount of \$170,000 from the Florida Department of Environmental Protection and authorize the City Manager to execute the grant agreement, in substantially the form attached, and all documents necessary or incidental thereto.

Background

The Florida Department of Environmental Protection Florida Recreation Development Assistance Program (FRDAP) has awarded grant funds to assist with the renovation of Carter Park. Grant funds will be used for a new playground, picnic facilities and landscaping and to renovate the football field, basketball courts and parking lot.

Grant-related work may not proceed until a Notice to Commence has been issued. The project completion date for this agreement is April 30, 2027. The executed agreement must be signed and returned to the state on or before November 18, 2024.

Resource Impact

This action will result in a positive impact to the City in the amount of \$170,000 with a City Match of \$170,000, which will be appropriated to the accounts below contingent upon the approval of the Consolidated Budget Amendment CAM 24-0981.
