Justice Assistance Grant Program.

The City has in the past been awarded and accepted the Edward Byrne Memorial Justice Assistance Grant (Byrne/JAG) Local Solicitation Program funding. The State receives these funds from the Department of Justice and then passes these funds through to units of local government.

The FY 2021 and FY 2022 Byrne/JAG awards were originally approved by City Commission on December 2, 2022, via CAM #22-1066 and CAM #22-1067. Since that time, terms of the grant memorandums of understanding (MOU) were changed to indicate that the Broward Sheriff's Office (BSO) will serve as the fiscal agent for the disbursement of all Byrne/JAG funds received.

In July 2024, BSO provided an amendment to the FY 2021 and FY 2022 Byrne/JAG memorandums of understanding to be executed by all Byrne/JAG sub recipients as required by the Department of Justice as Broward County is considered a disparate group. The amendment reflects BSO's designation as the Byrne/JAG fiscal agent. As such, in accordance with Resolution No. 14-62, the attached amended MOUs have been routed to the City Manager, who as the delegated authority to execute grant amendments on behalf of the City, once grant acceptance is approved by the City Commission.

THEREFORE, in consideration of the mutual terms, conditions, promises, and covenants hereinafter set forth, the participating agencies agree as follows:

Purpose

This MOU establishes the relationship between the parties for participation in the FY 2021 Edward Byrne Justice Assistance Grant (JAG) Local Solicitation Grant Program (Award Number 15PBJA-21-GG-01376-JAGX).

Procedures

1. **BSO** will serve as the lead agency and grant administrator for the agencies in Broward County, Florida participating in the JAG

Program. Pursuant to the JAG Program guidelines, funding for the JAG Program will be provided to the **BSO**.

- 2. The BSO shall then disperse the funds to the parties in the amounts determined by the JAG Program. For municipalities that currently contract with BSO for law enforcement services, the BSO shall retain the funds for use in the appropriate BSO Districts pursuant to the contracts for law enforcement services.
- 3. Each party shall be responsible for submitting its own application for their individual JAG Program to the **BSO**. The **BSO**, Grants Management Office will prepare the single application to include the Program Narrative and Budget Narrative, and shall submit the application to the Department of Justice.

- 1. This MOU shall remain in effect from October 1, 2020 through September 30, 2024, and its continuation shall be subject to the availability of necessary funding from the JAG Program.
- 2. A participating agency may withdraw from this agreement at any time by providing thirty (30) days written notice of its intent to withdraw to all other participating agencies.
- 3. This MOU may be terminated upon the written consent of all parties to this MOU.

Amendments

This MOU may be modified at any time upon the written agreement of all of the participating agencies.

Insurance and Indemnification

- 1. Each party agrees to maintain its own comprehensive general liability insurance, professional liability insurance, automobile liability insurance and workers compensation insurance policy or maintain a self-insuring fund for the term of the Agreement in the amounts determined by each party to adequately insure said party's liability assumed herein, but in no event shall such coverage be less than the amount of statutory waiver of sovereign immunity. The participating agencies agree to provide the **BSO** within thirty (30) days of entering this Agreement with proof of insurance if requested.
- 2. Each party shall be responsible for the negligent acts or omissions of their respective employees in accordance with Ch. 768.28, Fla. Stat. and nothing herein shall be deemed a waiver of those protections.

Guidelines

In performing its duties, responsibilities and obligations pursuant to this Agreement, each party agrees to: (i) adhere to the requirement standards set forth in the Office of Justice Programs' *Financial Guide*, as amended and Federal OMB Circular A-133, as applicable; and (ii), the special conditions FY 2021 Edward Byrne Justice Assistance Grant (JAG) Local Solicitation Grant Award issued by DOJ. All participating agencies shall enter into a formal sub-award agreement between the **BSO** as Sub-award Grantor and the participating agency as the Sub-award Grantee in a form substantially similar to the attached Exhibit 1.

Records

- a. Each party understands that any and all records created as a result of participating in this Program may be subject to public disclosure pursuant to the Public Records Statute, Fla. Stat. Section 119.07 and shall be responsible for compliance with any public records request served upon it and any resultant award of attorney's fees for noncompliance.
- b. Each party shall maintain its own respective records and documents associated with MOU sufficient to demonstrate compliance with the terms of this Agreement for a period of five (5) years from the date of execution of the MOU and shall allow the **BSO** access to such records upon request.
- c. Each party, its employees or agents, shall allow access to its records concerning this MOU at reasonable times to the **BSO**, its employees, and agents. The term "agents" shall include, but is not limited to, auditors retained or employed by the **BSO**. The term "reasonable" shall be construed according to the individual party circumstances but ordinarily shall mean during normal business hours of 8:00 am to 5:00 pm, local time, Monday through Friday.
- d. Upon reasonable notice, the participating agency shall provide the **BSO** with any additional documentation, information, or reports as may be required by the **BSO**.

Execution

This agreement may be executed in counterparts each of which shall be deemed an original and all of which together shall be considered one and the same agreement.

Recommendation

Staff recommends that the City Commission approve the acceptance of a grant in the amount of \$86,405 from the U.S. Department of Justice, subject to the City Manager's approval of the terms and conditions of any and all grant agreements in accordance with Resolution No. 14-62.

Background

The City has been awarded a grant in the amount of \$86,405 from the U.S. Department of Justice under the Edward Byrne Memorial Justice Assistance Grant (Byrne/JAG) Local Solicitation Program. The State receives these funds from the Department of Justice and then pass these funds through to units of local government. Broward County will manage the FY 2021 Byrne/JAG allocations for all participating municipalities. Justice Assistance Grant funding can be used for any local law enforcement initiative, and the City is permitted to use its discretion in deciding which projects to fund.

The Fort Lauderdale Police Department is eligible to receive \$86,405 in Byrne/JAG funding, less a 10% administrative fee of \$8,640.50 imposed by Broward County, for a total actual award of \$77,764.50. The Police Department has allocated this JAG funding to support investigative and public safety capabilities thru the purchase of essential forensic equipment such as an alternative light source and drying chambers. The grant period is October 1, 2020 through September 30, 2024.

Resource Impact

There is an anticipated positive fiscal impact to the City in the amount of \$77,764.50. This grant does not require matching funds. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 22-0896.

- A. County has been identified as a "disparate" county, such that County is permitted to submit a joint application for an allocation on behalf of County and the Participating Agencies.
- B. The Participating Agencies have been identified as eligible jurisdictions able to collectively implement the objectives and goals of the FY21 Edward Byrne Memorial Justice Assistance Grant (hereinafter "JAG Grant").
- C. The Participating Agencies formed a working committee and developed a course of action to achieve the goals and objectives of the JAG Grant.
- D. County has been selected, through this MOU, to apply for the JAG Grant, administer the program, and serve as the fiscal agent for the disbursement of all funds received for the JAG Grant.
- E. This MOU establishes the relationship between the Participating Agencies relating to the JAG Grant Award Number 15PBJA-21-GG-01376-JAGX.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Participating Agencies agree as follows:

- 1. The above Recitals are true and correct and are incorporated herein by reference.
- 2. <u>County's Responsibilities</u>. County will serve as the lead agency and grant administrator for the Participating Agencies for the JAG Grant. Pursuant to the JAG Grant guidelines, funding for the JAG Grant will be provided to County, and County will disperse the funds to the Participating Agencies in the amounts determined by County and submitted to the Department of Justice ("DOJ").
- 3. <u>Application Submission</u>. Each Participating Agency is responsible for submitting its own application to County for the JAG Grant, including a program narrative and budget narrative.

County, through its Office of Management and Budget, will submit a single application to the DOJ.

- 4. <u>Funding</u>. If the JAG Grant is awarded, County will distribute the funds to each Participating Agency in accordance with the JAG Grant and a separate Subgrant Award Agreement (as described in Section 8 below). For Participating Agencies that currently contract with the Broward Sheriff's Office ("BSO") for law enforcement services, County shall distribute the funds to the Participating Agency, which the Participating Agency may then distribute to BSO pursuant to any applicable contract(s) for law enforcement services.

Recommendation

Background

The City has been awarded a grant in the amount of \$90,952 from the U.S. Department of Justice under the Edward Byrne Memorial Justice Assistance Grant (Byrne/JAG) Local Solicitation Program. The State receives these funds from the Department of Justice and then pass these funds through to units of local government. Broward County will manage the FY 2022 Byrne/JAG allocations for all participating municipalities. Justice Assistance Grant funding can be used for any local law enforcement initiative, and the City is permitted to use its discretion in deciding which projects to fund.

The Fort Lauderdale Police Department is eligible to receive \$90,952 in Byrne/JAG funding, less a 7.02% administrative fee of \$6,384.83 imposed by Broward County, for a total actual award of \$84,567.17. The Police Department has allocated this JAG funding to support investigative and public safety capabilities thru the purchase of investigative equipment. The grant period is October 1, 2021 through September 30, 2025.

Resource Impact

There is an anticipated positive fiscal impact to the City in the amount of \$84,567.17. This grant does not require matching funds. This item is contingent upon the approval of the Consolidated Budget Amendment CAM 22-0896.
